As of February 7^{th,} I am still awaiting the formal fee proposal from Darrell Vickers at STV on the EMS Facility. Darrell has updated me stating that he is approaching this as a two-part proposal, with the initial phase being schematic site layout and building design and he will provide us with a rough order of magnitude for fees to proceed with design development and construction document phase drawings as soon as possible.

I met with USDA representative where we discussed the possibility of applying for a Community Facilities Direct Loan and Grant. During our discussion, it was highlighted that this funding opportunity is available year-round. The potential funding structure involves a combination of a grant covering 75% of the project costs, with the remaining 25% being provided as a loan repayable over 40 years at the current favorable rate of 3.75% I am working with USDA and will start with a pre-application once we know the amount for the building. A resolution from the Council will be needed to apply and I will bring this back once that is determined.

Due to a main water line break on 1/22/24 on Coffey St. The city was required to issue a boil notice. Public works employees worked diligently to resolve this issue in the quickest timeframe possible and we were able to lift the notice on 1/24/2024. I thank those employees who worked in the rain and cold for hours to return service to the citizens.

Change orders have been submitted with SWEPCO to change the streetlights along 259 between China Café and the Relax Inn to the new LED lights in the hopes that this will provide better lighting along this route. I have also asked for two new ones be installed near China Café.

As a reminder, the Chamber will hold their annual Banquet on March 2, 2024, at the Daingerfield High School Cafeteria.

Shall Article XIV, Section 2 of the City Charter of the City of Daingerfield be Amended to require an official copy of the Charter, as approved by the voters in accordance with state law, shall be filed with the records of the City, and the Mayor shall, as soon as practicable, certify to the Secretary of State an authenticated copy of the Charter with the approved amendments under the seal of the City, showing the approval by the qualified voters of such amendments to the Charter. Amendments to the Charter shall become effective when approved by the voters as provided by Texas law.

Proposition 2:

Shall Article XIV, Section 1 of the City Charter of the City of Daingerfield be Amended to require a Charter Review Commission composed of seven (7) members to be appointed by the City Council every four (4) years in the fourth quarter of the year to allow for review and updating of the City Charter.

Proposition 3:

Shall Article XI, Section 5 of the City Charter of the City of Daingerfield be Amended to require the City Manager to maintain a visible and accessible presence for the citizens of Daingerfield.

Proposition 4:

Shall Article XI, Section 2 of the City Charter of the City of Daingerfield be Amended to allow the City Manager to reside within 13 miles of the city limits instead of within the city limits of the City of Daingerfield after their appointment.

Proposition 5:

Shall Article IX, Section 2 of the City Charter of the City of Daingerfield be Amended to authorize the City Council if the City Council creates a municipal court of record as authorized by Chapter 30 of the Texas Government Code, the judge shall have the qualifications as required under Chapter 30 of the Texas Government Code, and that the municipal court judge serves at the pleasure of the City Council. The City Council may remove the judge of the Municipal Court or the judge of any municipal court of record authorized to be created by the City Council upon written notice and after a hearing before the City Council.

Proposition 6:

Shall Article IX, Section 1 of the City Charter of the City of Daingerfield be Amended to require the Municipal Court to have jurisdiction defined under Texas Government Code § 29.003], and Chapter 4 of the Code of Criminal Procedure. And to authorize the City Council to create a municipal court of record by ordinance under the authority of Chapter 30 of the Texas Government Code

Proposition 7:

Shall Article VI, Section 15 of the City Charter of the City of Daingerfield be Amended to require all meetings of the City Council to be conducted in accordance with the Texas Open Meetings Act under Chapter 551 of the Texas Government Code

Proposition 8:

Shall Article VI, Section 15 of the City Charter of the City of Daingerfield be Amended to require the Council to elect a Mayor Pro Tem from the Council who shall act as Mayor during the absence, disability, or if the Mayor refuses or fails to perform the duties of the Mayor.

Proposition 9:

Shall Article VI, Section 11 of the City Charter of the City of Daingerfield be Amended to require returns of the elections, general and special be made by the election officers to the City Council no earlier than the third day or later than the eleventh [(11th)] day following said election; at which time, the Council shall canvass and declare the results of such election.

Proposition 10:

Shall Article VI, Section 5 of the City Charter of the City of Daingerfield be Amended to require the regular election for the choice of members of the Council and Mayor to be held each year on the uniform election date in May.

Proposition 11:

Shall Article VI, Section 4 of the City Charter of the City of Daingerfield be Amended to require any member of the Council who has three (3) consecutive absences from Council meetings to forfeit the office, the forfeiture of office shall be automatic and shall not require any action of Council. Upon such forfeiture of office, the City Council may fill the vacancy thereby created in the manner authorized by this Charter or as otherwise allowed by Texas law. The forfeiture of such officer's office or employee's position shall be automatic and shall not require any action of the City Council in order to be effective, however, the City Council may take appropriate action to recognize such forfeiture.

Proposition 12:

Shall Article V, Section 6 of the City Charter of the City of Daingerfield be Amended to adopt a budget by a record vote and adopted in accordance and as required under Texas law.

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF DAINGERFIELD. **TEXAS, CALLING FOR AND ORDERING A SPECIAL ELECTION TO BE HELD** ON THE MAY 4, 2024 UNIFORM ELECTION DATE WITH A COMBINED BALLOT PURSUANT TO SECTION 321,409 OF THE TEXAS TAX CODE TO **DETERMINE WHETHER THE CITIZENS DESIRE TO REDUCE THE CURRENT ONE-HALF OF ONE PERCENT SALES AND USE TAX ALLOCATED FOR** PROPERTY TAX RELIEF TO ONE-FOURTH OF ONE PERCENT AND TO ADOPT A SALES AND USE TAX OF ONE-FOURTH OF ONE PERCENT TO FUND ECONOMIC DEVELOPMENT IN ORDER TO UNDERTAKE PROJECTS FOR THE PURPOSE OF ECONOMIC DEVELOPMENT AS DESCRIBED IN SECTION 501 AND 505, TYPE B CORPORATIONS, OF THE TEXAS LOCAL **GOVERNMENT CODE; ESTABLISHING PROCEDURES FOR THE CONDUCT** OF THE ELECTION; ESTABLISHING LOCATIONS FOR VOTING AND PROVIDING FOR THE DESIGNATION OF COUNTY POLLING PLACES AS VOTING LOCATIONS; SETTING THE HOURS FOR EARLY VOTING AND EARLY VOTING LOCATIONS: APPOINTING AN EARLY VOTING CLERK AND PROVIDING FOR THE APPOINTMENT OF ELECTION OFFICIALS: **PROVIDING A SEVERABILITY EFFECTIVE DATE CLAUSES; FINDING OF AN** EMERGENCY AND PROVIDING FOR THE IMMEDIATE ADOPTION AND PASSAGE OF THIS ORDINANCE; AND PROVIDING FOR RELATED MATTERS.

WHEREAS, the Development Corporation Act of 1979, formerly Article 5190.6 of the Texas Revised Civil Statutes, was codified at title 12, Subtitle C1, Section 501, et seq., providing for the creation of economic development corporations by municipalities for the purposes specified in the applicable provisions of the Development Corporation Act;

WHEREAS, by resolution of the City Council for the City of Daingerfield (the "City"), the City Council authorized the creation and formation of a Type B economic development corporation in the City of Daingerfield which is named as follows: Daingerfield 4-B Economic Development Corporation;

WHEREAS, the Daingerfield 4-B Economic Development Corporation was created to promote economic development within the City of Daingerfield in order to eliminate unemployment and underemployment, and to promote and encourage employment and he public welfare of, for, and on behalf of the City of Daingerfield by developing, purchasing, leasing, implementing, providing, and financing Projects under the Act and as Projects is defined in Chapter 505 of the Texas Local Government Code;

WHEREAS, Texas Local Government Code Chapter 505, Type B Corporations, is applicable to Type B Economic Development Corporations, provides for the levy of a sales and use tax for the benefit of a Type B Economic Development Corporation if the adoption of the sales and use tax is authorized by a majority of the qualified voters of the City of Daingerfield;

WHEREAS, the City has previously adopted by election, a sales and use tax of one-half (1/2) of one percent dedicated to property tax reduction;

WHEREAS, the City Council for the City (the "City Council") has determined that it is the best interest of the citizens of the City of Daingerfield to re-allocate the one-half (1/2) of one percent sales tax dedicated to property tax reduction by lowering that tax dedicated to property tax relief to one-fourth (1/4) of one percent and adopting a new sales and use tax of one-fourth (1/4) of one percent to support economic development projects of a Type B Corporation as described in the Development Corporation Act;

WHEREAS, due to the limitations on sales and use tax under the law, the City cannot legally collect sales and use taxes for the benefit of Daingerfield 4-B Economic Development Corporation and continue collection of the current sales and use taxes of one-half (1/2) of one percent for property tax relief;

WHEREAS, Section 321.409 of the Texas Tax Code requires the City Council of the City of Daingerfield to call a special election with a combined ballot for the purpose of determining if a majority of the citizens of the City of Daingerfield desire to reduce that tax dedicated to property tax relief to one-fourth (1/4) of one percent and adopting a sales and use tax of one-fourth (1/4) of one percent for the purpose of economic development as described in the Development Corporation Act; and,

WHEREAS, Article X, Section 8 of the Home Rule Charter for the City of Daingerfield, Texas, (the "City") authorizes the City Council to authorize to submit a proposition to the qualified voters of the City to consider the approval of the proposition to amend current Sales and Use Tax;

NOW, THEREFORE, BE IT ORDAINED AND ORDERED BY THE CITY COUNCIL OF THE CITY OF DAINGERFIELD, TEXAS:

Section 1. <u>Findings of Fact</u>. The findings and recitations set out in the preamble of this Ordinance are found to be true and correct and that they are hereby adopted by the City Council and made a part hereof for all purposes.

Section 2. Order of Special Election. The City Council orders a special election with a combined ballot to be held on Saturday, May 4, 2024, such date being a Uniform Election Date as set forth in the Texas Election Code, for the purpose of submitting to the qualified voters of the City the proposition on whether a majority of the citizens of Daingerfield desire to lower the current one-half (1/2) of one percent sales and use tax dedicated to property tax relief to a one-fourth (1/4) of one percent sales and use tax dedicated to property tax relief and to adopt a one-fourth (1/4) of one percent sales and use tax for the purpose of economic development as described in the Development Corporation Act. This election shall be held and conducted in accordance with the provisions of the Texas Election Code.

Section 3. <u>Submission of Proposition</u>. A proposition of whether desire to reduce the current one-half of one percent sales and use tax dedicated to property tax relief to one-fourth (1/4) of one percent and to adopt a one-fourth (1/4) of one percent sales and use tax for the purpose of economic development as described in the Development Corporation Act shall be submitted to the City's qualified voters for their approval or disapproval at an election to be held concurrently with the regular City election of City Council members on Saturday, May 4, 2024.

Section 4. <u>Levy of Sales and Use Taxes if Approved by Voters</u>. If a majority of the qualified voters shall vote in favor of the proposition and in favor of reducing the current one-half (1/2) of one percent sales and use tax dedicated to property tax relief to one-fourth (1/4) of one percent and to adopt a one-fourth (1/4) of one percent sales and use tax for the purpose of economic development as described in the Development Corporation Act, the City Council shall adopt ordinances levying the sales and use tax as lowered and adopted, if approved by the voters, in accordance with Texas Tax Code Chapter 321, the Development Corporation Act, and other applicable Texas state law, which shall, at the time fixed therein, become effective as law.

Section 5. <u>Election Held in Accordance with Election Code</u>. The special election ordered by this Ordinance shall be held in compliance with the provisions of Chapter 321of the Texas Tax Code, and, to the extent not in conflict therewith, the Texas Election Code.

Section 6. <u>**Proposition.**</u> The official ballot shall be prepared in accordance with the Texas Election Code so as to permit the electors to vote "For" or "Against" the proposition, with the ballots to contain such provision, markings, and language as required by law, and with such proposition as set forth in the attached draft ballot, or to be expressed substantially as follows:

PROPOSITION:

"The lowering of the current one-half (1/2) of one percent sales and use tax allocated for property tax relief to one-fourth (1/4) of one percent and to thereby adopt a sales and use tax of one-fourth (1/4) of one percent to be used to reduce the property tax rate and the adoption of a Local Government Code Section 505.251 sales and use tax of one-fourth (1/4) of one percent to undertake projects authorized by and described in Section 505 of the Development Corporation Act"

Section 7. <u>Ballots.</u> The ballots used for the general election shall comply with the Texas Election Code and shall be in the form provided by the City for use on the respective voting devices used by the City.

Section 8. <u>Printed Materials.</u> The official ballots, together with such other election materials as is required by the Texas Election Code, as amended, shall be printed in both the English and Spanish languages and shall contain such provisions, markings and language as required by law.

Section 9. <u>Notice of Election.</u> Notice of the election shall be given in the manner as provided in the Texas Election Code and the City Charter. The notice of election shall be posted on the bulletin board used for posting notice of meetings of the governing body at City Hall and at other locations required by state law not later than the twenty-first (21st) day before the election, and by publishing said notice of the election in a newspaper of general circulation, not earlier than thirty (30) days nor later than ten (10) days prior to said election. The City Secretary is authorized and shall give all notices required for the election.

Section 10. <u>Conduct of Election</u>. The City Secretary and his/her designees and appointees, and the election judges, alternate judges and clerks properly appointed for the election,

shall hold and conduct the election for the City. The election shall be held and conducted in compliance with the City Charter and state law.

Section 11. <u>Election Precincts and Election Day Polling Places</u>. The City has one (1) election precinct and said election shall be at the following place in said City:

J. D. Parrish Administration Building, 200 Tiger Drive Daingerfield, Texas.

Section 12. <u>Designation of Polling Place(s)</u>. The polls at the designated polling place(s) shall on said Election Day to be opened from 7:00 A.M. to 7:00 P.M. in the J. D. Parrish Administration Building, 200 Tiger Dr., Daingerfield, Texas. The City Secretary shall tabulate and provide the election returns for votes cast for the propositions presented to the voters to amend the City Charter.

Section 13. <u>Early Voting.</u> (a) Early voting by personal appearance shall commence on Monday, April 22, 2024, and continue through Tuesday, April 30, 2024, and early voting polls shall remain open for the time specified by the Texas Election Code and the respective Elections Administrator.

(b) The period to apply for a ballot by mail is January 1, 2024, through April 23, 2024. An application for ballot by mail (ABBM) must be received by the Early Voting Clerk no later than the close of business on April 23, 2024.

(c) The period to apply for a federal postcard application (FPCA) is January 1, 2024, through April 23, 2024. An FPCA must be received by the Early Voting Clerk no later than the close of business on April 23, 2024.

- (d) Early Voting Conducted by the City:
 - 1. Early voting, both by personal appearance and by mail will be conducted by the City Secretary in accordance with the Texas Election Code for the qualified voters of the City residing in the City. The City Secretary is hereby designated and appointed as an Early Voting Clerk for the general election for qualified voters of the City.

- 3. The main early voting location for qualified voters of the City is: the City Council Chambers in the Daingerfield City Hall located at 101 Linda Drive, Daingerfield, Texas 75638.
- 4. Early voting for qualified voters of the City shall be held at the dates, times, and location authorized by the City Secretary. Any early voting polling place may be added or changed by the City Secretary upon compliance with applicable law. Early voting by personal appearance shall only be conducted on one or more Saturdays or Sundays during the early voting period upon receipt of a written request submitted by at least 15 registered voters of the territory covered by the election as required by state law.

Section 14. <u>Election Judges and Clerks.</u> Prior to the Election Day, the election judges, alternate judges, clerks, and other personnel necessary for conducting the Election shall be appointed by the City Council or selected and appointed by the City Secretary, as authorized by the Texas Election Code, all in compliance with the requirements of state law, and they are hereby designated and appointed election officers for the holding of said election and such appointments are approved. The presiding judges, alternate presiding judges and clerks shall perform the functions and duties of their respective positions that are provided by state law. The City Secretary is authorized to appoint any such other officials not designated or appointed herein as are necessary and appropriate to conduct the Election in accordance with the Code.

Section 15. <u>City Secretary Assistance.</u> The City Secretary is further authorized to assist with the giving of notices required for the election, and to take such other and further action as is required to conduct the election in compliance with the Texas Election Code; provided that, pursuant to any applicable election services contracts, the City Secretary or the Elections Administrator, shall have the duty and be responsible for organizing and conducting the election in compliance with the Texas Election Code; and for providing all services specified to be provided in any applicable election services contracts.

Section 16. <u>Necessary Actions.</u> The Mayor and the City Secretary of the City, in consultation with the City's Attorney, are hereby authorized and directed to take any and all actions necessary to comply with the provisions of the Code and the Federal Voting Rights Act in carrying out and conducting the Election, whether or not expressly authorized herein, including but not limited to making changes or additions to polling places, ballot language, proposition language, or procedures to the extent required or desirable or as may become necessary due to circumstances arising after the date of this Ordinance, or as otherwise required in order to comply with state law. The City Secretary is further authorized to give notice of the election as required by the Texas Election Code. The Mayor is further authorized to sign any subsequent orders adjusting the polling locations, dates, and times that are subject to change due to any applicable joint election agreement, if any, up until the final posting deadline of such notice pursuant to Texas Election Code Sec. 4.003(a)(b) and (c).

Section 17. <u>General.</u> The general election shall be held and conducted by the City in compliance with the Texas Election Code and, to the extent not inconsistent therewith, the City Charter, and only resident qualified voters of the City shall be eligible to vote at the election. The Election Officers are hereby authorized and instructed to provide and furnish all necessary election supplies, materials, and equipment to conduct said election. Returns of the election shall be made

known as soon as possible after the closing of the polls; and the election returns shall be canvassed by the City Council not earlier than May 7, 2024, nor later than May 15, 2024.

Section 18. <u>Authorization to Execute.</u> The Mayor is authorized to execute and the City Secretary is authorized to attest this Ordinance on behalf of the Council; and the Mayor is authorized to do all other things legal and necessary in connection with the holding and consummation of the Election.

Section 19. <u>Effective Date: Election Code: Preamble.</u> This Ordinance shall be in full force and effect from and after its passage on the date shown below; provided that if any term or provision of this Ordinance conflicts with, or is inconsistent with, the Texas Elections Code, the Texas Election Code shall govern and control and the City Secretary shall comply with the Texas Elections Code. The recitals contained in the preamble hereof are hereby found to be true, and such recitals are hereby made a part of this Ordinance for all purposes as part of the findings of Council.

Section 20 <u>Severability.</u> If any provision, section of this Ordinance or the application of any provision to any person or circumstance is held invalid, the invalidity shall not affect other provisions or applications of the Ordinance which can be given effect without the invalid provision or application, and to this end the provisions of this Ordinance are declared to be severable.

Section 21. <u>Open Meetings.</u> It is officially found and determined that the meeting at which this Ordinance is passed was open to the public as required and that public notice of the time, place, and purpose of said meeting was given as required *Chapt. 551, Tex. Gov't. Code.*





Minutes of January 25, 2024, Meeting

 The regular meeting of the Daingerfield 4A/4B Economic Development was called to order by President Keitha Nilsson at 4:03 PM. Also, in attendance were Directors: Beverly Austin, Secretary/Treasurer, Walter Bass, Jason Horn, Brenda Howard, and Chris Smith. Also in attendance was Michelle Jones, Interim City Manager/City Secretary, City of Daingerfield (903-645-3906).

Visitors present were: Lisa and Bryan Hydrick; and Tegra and Torre Chism

- 2. Review and Possibly Approve the Act to Elect Officers for the Daingerfield Economic Development Corporation. The Board voted unanimously for Chris Smith, President; Jason Horn, Vice-President; and Beverly Austin, Secretary/Treasurer.
- 3. Review and Possible Action to approve Minutes of Last Meeting: After a review of the minutes of the October 25, 2023, meeting, the Minutes were approved by a motion made by b Jason Horn. With a second by Chris Smith. Motion passed.
- 4. Review and Possible Action to approve Financial Reports. Upon review of the Rural Business Enterprise Grant and Administrative account, a motion was made by Chris Smith with a second by Walter Bass. Motion passed unanimously.
- 5. Review and Possible Action to approve community projects to submit to the Daingerfield City Council paid for from the 4B Economic Development Corporation funds. Kyle Harrison, President, Daingerfield Lone Star Youth Sports Association suggested areas of focus for upgrades/improvements to Irvin Park ("Park"). Up until January 8, 2023, the Park was owned by the Daingerfield Lone Star Youth Sports Association ("Association"). On January 8, the Daingerfield City Council agreed to approve a resolution accepting a general warranty deed from the Association, giving the city ownership of the Park. Brenda Howard reported on the 4B Budget items and stated that upgrading the Park was the number one priority of the DF EDC Budget Committee. Mr. Harrison reported that when he became President of the Association in 2020, his goal was to make improvements, his priority being the restrooms. Mr. Harrison submitted a written report (attached) of the desired upgrades and some estimates. He stated that with improvements of the restrooms he believed they could book more tournaments. Michelle Jones reported that a grant may be sought up to \$150,000 to assist with long-term improvement goals. After exhaustive discussion, the Board agreed to recommend remodeling the restrooms, installing air conditioning ducts, and adding more stalls. The Board also agreed to add a screen mesh to enclose the wastewater site. Ms. Jones stated that since the cost would be over the \$10,000 threshold, that it would require a hearing and that at least three bids should be submitted. Ms. Howard made a motion to approve the improvements to the Park, with submission of three bids, to be

- 6. The Daingerfield EDC Board discussed the potential purchase of the historic church located at 509 Taylor Street, Daingerfield, Texas as a possible community facility. Realtor Lisa Hydrick reported that the church, built in the 1800s, was for sale for the asking price of \$199,000 with one offer pending. The board discussed the possibility of creating a community recreation facility based on a community poll that expressed the community's desire for such a place. Mrs. Austin reported that a 2019 survey conducted by the Morris County Collaborative had also shown a need for more recreational places in the community. However, concerns were raised about the cost of upkeep and maintenance for the building, as well as the lack of adequate funds to support the purchase and maintenance without the benefit of Sales Tax Allocation vote pending in the upcoming may 2024 election. Further discussion and evaluation of the potential purchase will be necessary. The Board agreed to table the action. The motion to table was made by Ms. Nilsson and was seconded by Mr. Horn.
- 7. Review and Possible Action to Recommend a 2nd Lien Loan for Chism Investment Properties LLC. Torre and Tegra Chism were requesting a business loan of \$70,000. Mrs. Chism stated they would hire one employee with part of the proceeds. The Board agreed to approve \$25,000 of the \$70,000 requested due to the present Loan Policy which mandates that for every \$25,000 in loan proceeds, there must be one employee hired. Ms. Howard will notify the Chisms of the loan decision. A motion was made by Ms. Howard to approve the loan for \$25,000 and seconded by Walter Bass. The motion passed unanimously.
- 8. Adjournment A motion to adjourn was made by Mr Horn and seconded by Chris Smith. The motion passed.
