- A. Deliberate and Possibly Act to Approve the Scope of the Proposed EMS Facility: Consultants from CP&Y, who were approved in March 2023 to act as the city's consultants on the project to build a permanent Air Methods/EMS building on the same site as the Fire Department will be present. At this discussion Council will identify the scope of the project and CP&Y will then prepare an official scope and fee document, the total cost for the study will be determined after the meeting and presented to Council for review and execution before CP&Y starts work.
- B. Deliberate and Possibly Act to Approve an Ordinance allowing a Discount on Water Rates to the Residents Affected by the ongoing Boil Water Notice located at Wildwood Dr., Freeman Ave., Ewan Blvd., Rutledge Blvd., Irvin Pkwy., Gifford Ave and West Elementary: There are 54 active connections that are currently being affected by the Boil Water Notice that has been ongoing since August 30, 2023. At this time, it is being requested to approve a 30% discount on the residents' water rate until such time as the boil water notice is lifted and service has been restored to normal.
